After treating the skin model EpiDerm™ with this product for 60 min, the average value of relative tissue vitality decreased to 5.2%. This value is lower than the threshold of skin irritation probability (50%). Test items with permeability value lower than 50% threshold are considered to be at least irritating to skin
